Minutes

1. Opening of the AGA

The President welcomed all members.

2. Review and Approval of Minutes 2018

The minutes and action points were reviewed. No remark was made, the minutes were unanimously approved.

3. Presidential Report

The President mentioned that he was starting his 3rd year of Presidency and gave a report. His full report is available here:

He was proud to announce that the society was going very well with 5'400 members. According to him it was the biggest anaesthesiology society in Europe, with real active members. The President also underlined that 2/3 of congress attendees were ESRA members which showed that the members were more active than in the past. He also mentioned that more and more attendees were coming from outside Europe and stressed that the enthusiasm of a number of ESRA zones was very important. Thanks to it even small countries could have a big number of ESRA members.

Another fact reported was that by taking all the ESRA events organised during the year, the society reached 1'000 more attendees in 2019 than in 2018.

The President also explained that the relation with ASRA changed with a clear agreement for the RAPM journal. He mentioned that ASRA accepted to decrease the fees for the journal and that thanks to it ESRA was able to decrease the membership fees for some categories and to offer an online only option.

The President announced that a new ESRA academy will be launched soon, which will be more user friendly and that a new tool was available for free to all members, the USabcd eLearning platform.

The other points reported by the Presidents were the importance of the Prospect recommendations and the guidelines developed by the society. He also mentioned the impact of the PCO and the necessity to have competition.

To conclude his report the President reported that the Carl Koller award 2020 had been awarded to Marc Van de Velde and that Luc Mercadal had been selected for the recognition of education in regional anaesthesia award.

The President thanked the ESRA Office, the Board and Council members and the diploma Boards. José De Andrés was specifically thanked for his 33 years in the ESRA Board.

4. Secretarial Report

He reported that the terms of reference for the committees were updated and presented the Chairs of all ESRA committees. Another topic covered by the General Secretary was the bylaws 2019. He reminded that all members received the suggested changes before the meeting but reported a discussion that took place during the Council meeting. The General Secretary presented the bylaws with the suggested changes and explained that they were all regarding the position of the Residents & Trainees representative in the Board. He added that the voting rights for this position were intensively discussed during the Council meeting and that all Council members agreed that it was logical that all Board members would have the same power and therefore the Residents & Trainees representative in the Board should also have voting rights. A vote to accept the changes in the bylaws took place and the changes were unanimously approved.

5. Elections 2019

The General Secretary went on by announcing the elections that took place during the Council Meeting that needed to be approved by the General Assembly. He reported a gap in the bylaws regarding the voting rights which will need to be corrected as Council members elected by the zones to represent them had voting rights, the Board members were elected by and from the Council but the question was whether the Board members should have voting rights in addition to the Councillors or not. He mentioned that after discussion it was agreed at the Council meeting for this election period to give all Board members 1 vote but to clarify it for the next General Assembly.

He announced that the results of the elections were:

A vote to approve the elections took place and all elections were unanimously agreed by the general assembly.

6. Financial Report

She mentioned that the former Treasurer Geert Jan Van Geffen helped her to prepare the 2018 report as he was still Treasurer in 2018 but that unfortunately he was unable to attend the meeting as he was currently at a workshop.

The Treasurer reminded that the 2 main sources of income for the society were the congress and the membership revenues. She explained that the congress in Dublin was very successful but the costs were higher and that in 2018 the membership revenues increased but because part of the income was already received in 2017 when the membership registration started in October and part of it was still received in 2019, the membership revenue 2018 decreased in the accounts.

She reported that the costs for the Office increased since an additional person was working in the secretariat, the costs for the meetings increased as well as the Council had more members, more countries were involved and many more activities were taking place. She further mentioned that the costs for members also increased due to the higher number of members and the diplomas costs increased as well because the diplomas expended, the format changed and more meetings were necessary but that it was something positive for the society. The Treasurer reminded that the purpose of the society was not to deposit money in a bank account but to use it for educational activities.

The Treasurer went on by presenting the budget for 2019. She explained that 2019 will be a better year with a higher income from the membership and the congress as well as some income from the bank products. She added that the membership costs will decrease thanks to the new contract with

the RAPM and announced that a profit of about 200'000 Euros was expected which the society will be able to invest in future activities.

A vote to approve the 2018 financial report took place, the report was unanimously accepted. The Treasurer was thanked and congratulated for the very clear report.

7. Miscellaneous

No other topic was discussed.

8. Questions and Remarks

A question was raised about the decisions for investments, it was asked who was taking the decisions. The Treasurer answered that until this day the Major Officers were taking the decisions after having received the advice from the bank but that for the future the Board should decide and that she wanted to have a financial advisor. It was mentioned that the society could either be conservative or risky with its investments and that until now it was conservative. The Treasurer added that the society was in the process to look for other banks to compare the different offers available. It was mentioned that Belgium was the only country where negative interest rates were prohibited by law.

No other question or remark was made. All members were thanked for their attendance.
